Extracurricular and cocurricular activities are recognized as an integral parts of the educational program. Students are strongly encouraged to participate in such activities, while giving their academic work the priority it deserves.

Extracurricular and cocurricular activities sponsored by the School District of Altoona, including organized interscholastic and intra-District athletics and fitness opportunities, promote school loyalty and pride within the student body and encourage community participation. For all activities we place a value on teamwork, communication, camaraderie and giving your best effort. When competition is involved the board places top priority on fair competition and sportspersonship, rather than, just a victory. Such activities provide many opportunities to teach the values of teamwork, participation, competition and sportspersonship.

The board believes that these benefits should be made available to as many district students as practical. Furthermore, when competition is involved, the Board places top-priority on the values of teamwork, fair competition and sportspersonship rather than on winning.

For extracurricular athletics, the Board adopts the eligibility standards set by the Wisconsin Interscholastic Athletic Association (WIAA).

When an activity involves a new or substantially modified funding and/or staffing obligation, it will be approved by the Board or by the Superintendent or building principal when the activity does not involve such additional budgetary or staffing obligations.

The District shall not unlawfully discriminate in admission to or participation in any program or activity, standards and rules of behavior, disciplinary actions or facilities usage on the basis of the person's sex, race, religion, national origin, color, ancestry, creed, pregnancy, marital or parental status, sexual orientation, physical, mental, emotional or learning disability, or any other legally protected status or classification. This policy does not, however, prohibit the District from placing a student in a program or activity based on standards of individual performance, or from providing separate programs and facilities in interscholastic athletics for males and females if such programs and facilities are sufficiently comparable in type, scope, and support from the District. Discrimination complaints shall be processed in accordance with established District procedures.
